Fee Guidelines

CAMS panelists are independent. Our fee schedule represents guidelines for most cases. Discuss individual panelist fees with the panelist you choose. Likewise, reasonable facility fees may be requested, depending upon the panelist.

Reservation Fee Credited to the payor in the first hour of mediation. If mediation to be scheduled within 30 days, full estimated amount is due before scheduling.	\$250 to be paid when mediation date reserved. Fee reserves date for 15 days pending receipt of full payment. To be applied to the mediation fee when confirmed. Nonrefundable.
Mediation upon agreement of all parties indicated by signatures on Order form or written (email) confirmation by all parties and/or counsel.	Starting at \$400/hr. Min. 4 hours payable at the Time mediation date confirmed. Divided equally among the parties. Payment MUST be Received by the Mediator BEFORE mediation date confirmed.
Binding Arbitration Commercial Must be by way of a written stipulation, court order or a self executing arbitration provision in a contract. (Generally to be completed with pre-arb document exchange; hearing in one day.	\$2,500 per day scheduled (or any part of a day) plus \$500 to write award. Payment MUST be received by the Arbitrator BEFORE the Arbitration will begin work. * ask arbitrator about refund policy.
Non-Commercial Binding Arbitration Must be by way of a written stipulation, court order or a self executing arbitration provision in a contract.	\$475/Hr., Minimum 10 hours. Deposit based upon time estimate of counsel. Payment MUST be received by the Arbitrator BEFORE the Arbitration will begin work.
Special Master/Referee	\$425/hr. 10 hour deposit at the time appointment accepted. Billed monthly. Must have order appointing CAMS professional that includes fees and apportionment.
Confidential Mediator Evaluation	\$1,500 for most cases. Depending upon length of review. Contact Panelist for quote.
Family Law/Divorce	Contact your individually selected CAMS professional for details.
Facility Fee	CAMS Facility: \$200.00 flat fee; Other Locations: As charged by the facility. Discuss with selected panelist. Paid concurrent with mediation deposit.
Travel Time	\$150/hr. plus mileage per MapQuest or similar software (outside of the Western/Northern I.E.) portal to portal from panelist's personal office. Per the individual panelist. *discuss with chosen panelist.
Cancellation	One Hour if cancellation 30 days or more before confirmed date; 50% refund 15-30 days before confirmed date; no refund if cancelled less than 15 days before confirmed date. This also applies to facility fees.
Continuance	No charge 30 days or more before scheduled date; 1 hour 15 - 5 days; 2 hours within 5 days (except for bona fide emergency).
